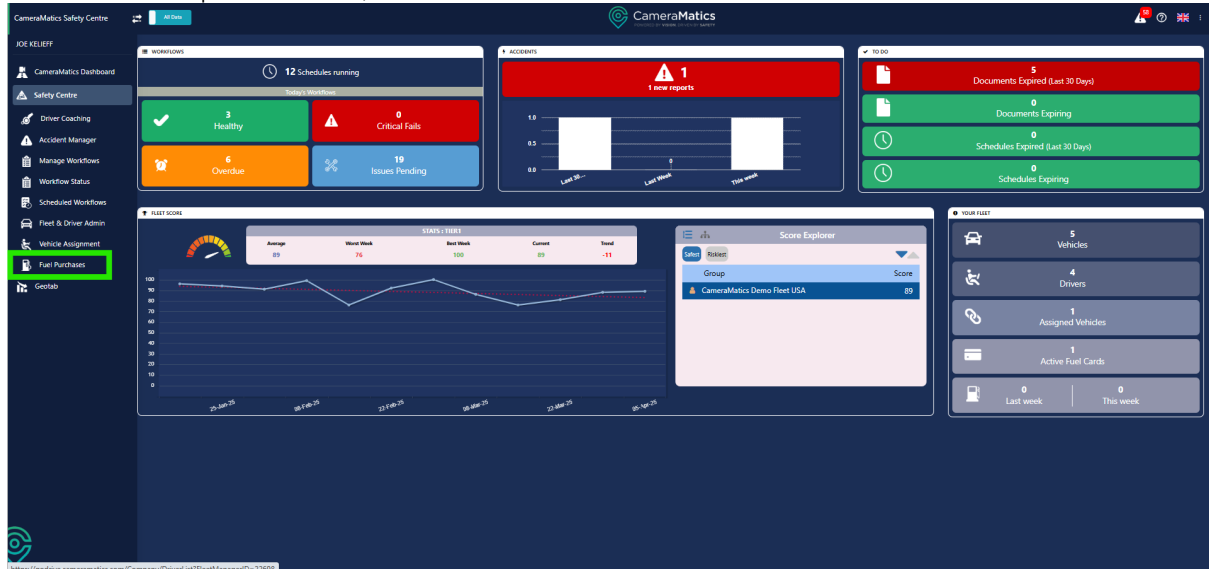
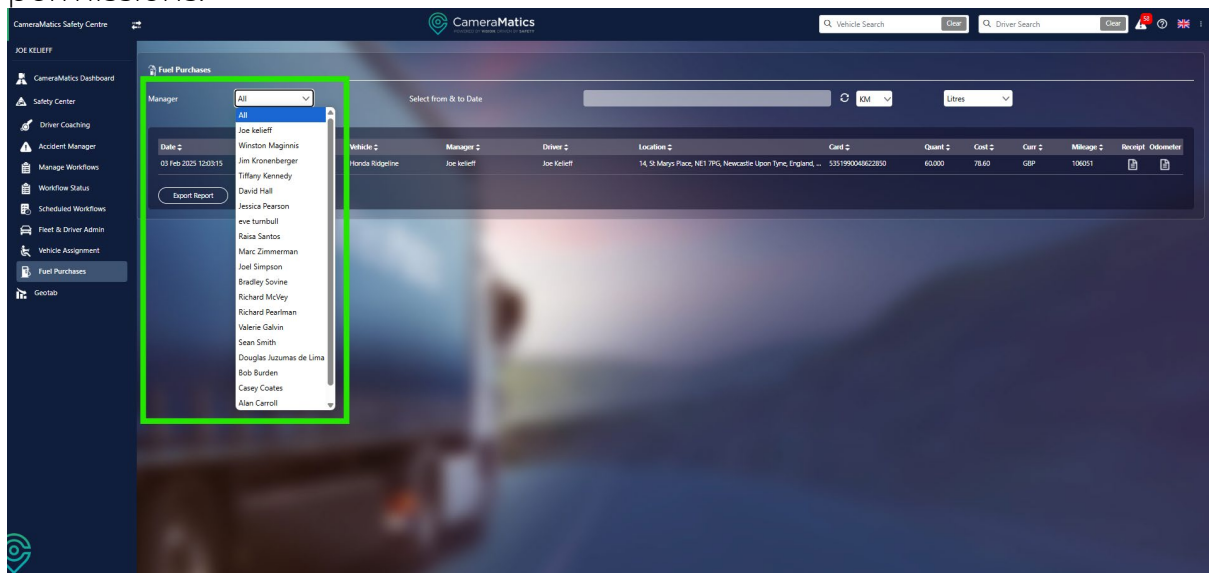


How to View Fuel Purchases, and Export this Report


